FLOWER SHOW GENERAL RULES

- This Flower Show conforms to the standards established by National Garden Clubs, Inc. (NGC). The Handbook for Flower Shows (HB), 2017 Edition, with revisions posted on the NGC website, is the authority for all issues not covered by the Flower Show Schedule, which is the Law of the Show.
- 2. All Classes are open to members of the National Garden Clubs, Inc., and by invitation, except for the Photography section which is restricted to members of The Garden Club of Stuart, Inc.
- 3. Pre-registration of all Flower Show entries is required by means of the prescribed form, where necessary, and may be submitted by email, regular mail, or in person with the appropriate Entries Chairman. See individual Division Rules for further entry procedures.
- 4. Pre-registered entries will be accepted at the Flower Show venue located at Indian River State College, 2400 SE Salerno Road, Stuart, Florida, as stated in the timetable on the inside front cover of this Flower Show Schedule.
- 5. Each entry must be the work of only one exhibitor unless otherwise stated in the pertinent Division Rules.
- 6. The Classification Chairman for each Division checks exhibits for conformity to the Schedule prior to judging. Final determination for conformance is the Judges' responsibility.
- 7. Judging for the Flower Show will commence at 10:00am on Friday, March 3, 2023. The Flower Show Chairman and the Classification Chairmen for each Division are available during judging for possible consultation. They, along with the Judges and Clerks, are the only personnel allowed on the floor during the judging.
- 8. Decisions of Judges are final. Awards may be withheld if not merited.
- 9. The general Flower Show Chairman will be available and on premises at all times during the Show.
- 10. There must be an emphasis on fresh plant material; no artificial plant material is permitted in any exhibit in any Division. Living members or taxidermy representations of the Animal Kingdom are prohibited.
- 11. Exhibitor is limited to one (1) entry per Class except in Division II Horticulture and in Division IV Botanical Arts Photography. See respective Division Rules for further clarification.
- 12. The Garden Club of Stuart, Inc. will strive to assure the safety of all items after arrival and placement but is not responsible for any loss or damage to exhibits.
- 13. Exhibits from all Divisions MUST be removed from the show venue hall on Saturday, March 4 no sooner than 3:00pm and no later than 4:30pm. If unavailable at this time on Saturday, the exhibitor should arrange for someone else to remove their entry. Any remaining entries may be disposed of without notification.
- 14. Entry cards of all blue ribbon-winning exhibits must be signed and dated by an NGC Accredited Judge on the judging panel. Top Exhibitor Award ribbons must be signed and dated as well.

- 15. All non-blue ribbon exhibits scoring 90+ points must be so designated on the entry card and signed and dated by an NGC Accredited Judge on the judging panel.
- 16. All other entry cards may be marked with a check, hole punch or other mark to note the exhibit was judged.
- 17. The use of plant material classified as Federal Noxious Weeds or Florida Prohibited Aquatic Plants is prohibited.

18. The use of plant material included on Florida's Federally Listed Plant Species as endangered or threatened is prohibited.

19. Invasive plants are prohibited.

20. Florida native plants may be entered provided such plants have been legally obtained and grown by the exhibitor for at least three (3) months.

FLOWER SHOW AWARDS

The NGC Standard System of Awarding is used in all the Divisions (HB p. 5). Ribbons may be offered as specified below. Award must be withheld if the exhibit does not meet the point value for the ribbon.

- a) Only one (1) First Place (blue ribbon) per class or sub-class scoring 90 points or more
- b) Only one (1) Second Place (red ribbon) per class or sub-class scoring 85 points or more
- c) Only one (1) Third Place (yellow ribbon) per class or sub-class scoring 80 points or more
- d) One (1) or more Honorable Mention (white ribbon) per class or sub-class scoring 75 points or more

Sweepstakes Award

(rosette of green and white ribbons)

Awarded to the exhibitor winning the most blue ribbons in the overall Flower Show. In case of a tie, the tie will be broken by counting red ribbons.

DIVISION I – DESIGN NGC Top Exhibitor Awards

DIVISION AWARD

Award of Design Excellence – (rosette of gold ribbons)

Awarded to the highest scoring 95 or more blue ribbon exhibit in the entire Design Division. (HB p. 42)

SECTION AWARDS

Awarded to the highest scoring 95 or more blue ribbon winner in a Section. A minimum of four (4) exhibits are required in each Class.

Designer's Choice Award – (rosette of purple ribbons)

Awarded to the highest scoring exhibit in Section A. Exhibitor has complete freedom to choose plant materials and other components within NGC policies. (HB p. 42)

Table Artistry Award – (rosette of burgundy ribbons)

Awarded to the highest scoring exhibit in Section B. (HB p. 43)

Tricolor Award – (rosette of red, blue, and yellow ribbons)

Awarded to the highest scoring exhibit in Section C. All plant material must be fresh. (HB p. 43)

Petite Award – (*small rosette of blue and white ribbons*)

Awarded to the most outstanding petite design in Section D within a show of otherwise full-sized designs. (HB p. 43)

DIVISION II – HORTICULTURE NGC Top Exhibitor Awards

DIVISION AWARD

<u>Award of Horticulture Excellence – (rosette of green, orange, and blue ribbons)</u>
Awarded to the highest scoring 95 or more blue ribbon exhibit in the entire Horticulture Division. (HB pp. 39,40)

SECTION AWARDS

Awarded to the highest scoring 95 or more blue ribbon exhibit in a Section. No minimum number of exhibits required per Class.

<u>Grower's Choice Award</u> – (rosette of dark green ribbons)

Awarded to the highest scoring container-grown plants. One (1) award may be awarded in each of Sections A, B, C and H. (HB pp. 39,41)

<u>Award of Merit</u> – (rosette of orange ribbons)

Awarded to the highest scoring cut non-woody specimens including vines. One (1) award possible in each of Section D, E, and F. (HB pp. 39,41)

<u>Arboreal Award</u> – (rosette of green ribbons)

Awarded to the highest scoring cut tree or shrub specimens in Section G. (HB pp. 39,40-41)

DIVISION III – EDUCATION NGC Top Exhibitor Award

Educational Top Exhibitor Award – (rosette of brown and white ribbons) Awarded to the highest scoring 95 points or more blue-ribbon exhibit. (HB pp. 39,43-44)

DIVISION IV – BOTANICAL ARTS NGC Top Exhibitor Awards

SECTION AWARDS – (HB pp. 39,44-45)

<u>Botanical Arts Artistic Crafts Award</u> – (rosette of navy-blue ribbons) Awarded to the highest scoring 95 points or more blue-ribbon exhibit in Section A.

<u>Botanical Arts Photography Award</u> – (rosette of black and white ribbons) Awarded to the highest scoring 95 points or more blue-ribbon exhibit in Section B.

DIVISION I – DESIGN DESIGN RULES

(HB pp. 28-29, 79-81)

- 1. The NGC Exhibit Policies are printed in the Handbook for Flower Shows, Chapter 7, Exhibiting in the Design Division, NGC Policies and Guidelines.
- 2.All General Rules on pages 6-7 of the Schedule apply.
- 3. Advance registration must be made with Design Entries Chairman Conchita Vallecillo (phone: 703.300.4791, email: conchi_v@yahoo.com) no later than February 13, 2023.
- 4.Design entries are open exclusively to members of NGC affiliated garden clubs. Designs may be entered at the show venue hall on Thursday, March 2, 2023, from noon to 4:00 pm.
- 5. If the design exhibitor is unable to fulfill the advance registration commitment, it is the exhibitor's responsibility to find a replacement design exhibitor and to notify the Design Entries Chairman.
- 6.A design entered in the show must be the work of only one (1) exhibitor and that exhibitor's name must appear on the entry card.
- 7.An exhibitor may enter multiple classes within the Design Division although only one (1) exhibit may be entered in each Class.
- 8.Entry cards will be provided by the Design Entry Committee at the exhibitor's entry site. Plant material used in the design must be listed by the exhibitor (botanical and/or common name is acceptable) on a blank 3" x 5" card also provided by the Committee and displayed with entry card. A brief interpretation of the design may be included on separate 3" x 5" card. Exception: Because of a lack of space, entry cards in the Petite Section will be 2 ½" x 4". The same rules apply to these cards as for all other sections.
- 9. Some plant material must be included in every exhibit. This includes fresh and/or dried plant material. The Schedule may stipulate type of plant material to be used. A single flower or a container-grown plant is never considered a "floral design." Plant material need not have been grown by the exhibitor.
- 10.Plant material and non-plant material permitted and not permitted in the Design Division are printed in the Handbook for Flower Shows, Chapter 7 (pp. 80-81).
- 11. The exhibitor is required to conform to the stated description and limitations of the design type if named in the Class.
- 12. Rules for design types, advanced design types, table designs and table appointments are printed in the Handbook for Flower Shows, Chapter 7 (pp. 70-79).

- 13.Exhibitor is on his/her honor to ensure that the design being entered has not been previously entered or judged in an NGC Flower Show.
- 14. The exhibitor has the freedom to choose Traditional or Creative style with any design listed for each Class unless restricted by the Schedule.
- 15. Fresh plant material may not ever be treated in any manner.
- 16.Dimension limitations of the allotted space (frame of reference) and all staging equipment is stipulated in the requirements for each Class. Staging items that the design exhibitor may/must provide are also listed for each Class.
- 17.Landscapes or scenes are not permitted in the Design Division.
- 18. The national flag of the United States of America, or flag of any other nation, is not permitted in any design. The use of any official national flag as an underlay, background, skirting, draping, etc. is also prohibited.
- 19.Religious symbols must be displayed in a respectful manner in accordance with policies of local religious organizations.
- 20. The exhibitor's design must be approved for adherence to NGC policies and schedule requirements by the Design Classification Chairman prior to the exhibitor leaving the show venue as printed in the Handbook for Flower Shows, Chapter 2 (p. 15).
- 21. Judges are requested to provide comments on all exhibits except for the blue-ribbon winners and must sign the entry cards of all designs scoring 90 points or more.
- 22. Judging of the Designs is based upon the following Scale of Points:

Section A - ODE TO JOY (Ludwig Van Beethoven)

Eligible for one Designer's Choice Award

Exhibitor's choice of plant materials and other components.

Four (4) entries per class

Design Consultant: Susan Slater 908.451.3541

Class 1 Bolero (Maurice Ravel)

A **Creative Design** staged on one half (36") of a six foot long by 24" deep and 29" high table draped to the floor in black. Design to be situated in front of a 46" high x 48" wide black trifold niche (including 12" wings) provided by Committee. (Frame of reference is 36" W x 24" D x 46"H)

Exhibitor may provide colored underlay and/or background material.

Class 2 Reverie (Claude DeBussy)

A design to <u>complement</u> a work of art, e.g. an original painting, print, sculpture, collage, mobile, etc. It need not be a piece created by the exhibiter and must fit within the assigned niche. Exhibiter may use **any design type** that is recognized and identified by the NGC and must be clearly listed on a separate card and placed with the display. Staged on one half (36") of a six foot long by 24" deep and 29" high table draped to the floor in black. Design to be situated in front of a 46" high x 48" wide black trifold niche (including 12" wings) provided by Committee. (Frame of reference is 36" W x 24" D x 46"H) Exhibitor may provide colored underlay and/or background material and must furnish own easel or stand if needed.

<u>Class 3</u> March of the Toy Soldiers (Tchaikovsky)

A **Parallel Design** staged on one half (36") of a six foot long by 24" deep and 29" high table draped to the floor in black. Design to be situated in front of a 46" high x 48" wide black trifold niche (including 12" wings) provided by Committee. (Frame of reference is 36" W x 24" D x 46"H) Exhibitor may provide colored underlay and/or background material

Section B ROMEO AND JULIET

(Pyotr Ilyich Tchaikovsky)

Eligible for one (1) Table Artistry Award

Exhibitor's choice of plant materials and other components Four (4) entries per class

<u>Class 4</u> **A MIDSUMMER NIGHT's DREAM** (Felix Mendelssohn)

Novice Class – Open only to exhibitors who have not previously won a blue ribbon in Design in an NGC Flower Show.

A romantic **Tray for One** staged on a 26" long by 14" deep and 4" high black platform (provided by the Committee) placed on one half (36") of a six foot long by 24" deep and 29" high table draped to the floor in black. Staging table backs up to a wheat-colored wall. The decorative unit should be in proportion to the one (1) place setting. A tray is a <u>Functional Table</u> design. Exhibitor must provide tray not to exceed 26" long by 16" deep.

<u>Class 5</u> **FANCY FREE** (Leonard Bernstein)

An **Exhibition Table** not meant to be functional, staged on one half (36") of a six foot long by 24" deep and 29" high table draped to the floor in black. Staging table backs up to wheat-colored wall. Plant material must be used as needed for the overall design. Exhibitor may provide underlay and background staging panel/material. Underlay not to extend beyond the front edge of the table. The design or background staging panel is not to exceed 46" high.

<u>Class 6</u> **MOONLIGHT SONATA** (Ludwig van Beethoven)

A **Functional Table for Two** staged on a 36" round table 29" high draped to the floor in black . Exhibitor may provide underlay. Freestanding exhibits to be viewed and judged from all sides.

Section C 'Morning Mood'

from Peer Gynt (Edvard Grieg)

Eligible for one (1) Tricolor Award.

Only fresh plant material allowed Four (4) entries per class

Class 7 CRISANTEMI (Giacomo Puccini)

A **Creative Line Design** using <u>Chrysanthemums as the main flowers</u>. Foliage and line material allowed. Staged on one half (36") of a six foot long by 24" deep and 29" high table draped to the floor in black. Design to be situated in front of a 46" high x 48" wide black trifold niche (including 12" wings) provided by Committee. (Frame of reference is 36" W x 24" D x 46"H) Exhibitor may provide colored underlay and/or background material

Class 8 A COLOUR SYMPHONY (Arthur Bliss)

A **Victorian Design** staged on a 28 1/2" H table with a 29 1/2" round top, draped to the floor in black, and situated in front of off-white horizontal blinds covering a window. No staging panel allowed. Design to be viewed and judged from the front only. Exhibitor may provide an underlay which will extend no more than 15" below round top.

<u>Class 9</u> **CLAIR DE LUNE** (Claude Debussy)

A **Reflective Design** staged on one half (36") of a six foot long by 24" deep and 29" high table draped to the floor in black. Design to be situated in front of a 48" high x 48" wide black trifold niche (including 12" wings) provided by Committee. (Frame of reference is 36" W x 24" D x 48"H) Exhibitor may provide colored underlay and/or background material.

Section D

Petite Suite (Claude Debussy)

Eligible for one (1) Petite Award

Exhibitor's choice of fresh and/or dried plant material.

Four (4) entries per class

Design Consultant: Louise White

Staged on one quarter (1/4) of a 22" round, 48" H black pedestal. Allocated space 5" W x 10" H black background panel with 7" L x 10"H wings, depth 8" at edge of table. Underlays and staging panel permitted, but not to exceed depth or width of allocated design space.

<u>Class 10</u> Flight of the Bumblebee (Nikolai Rimsky- Korsakov)

9" **Multi-Rhythmic Design**. Design may not exceed 9" in height and 5" in width. Fresh and/ or dried flowers may be used

Class 11 Water Games (Maurice Ravel)

7" **Cascade Design**. Design may not exceed 7" in height and 5" in width. Fresh and/or dried plant material.

Class 12 OCEAN SYMPHONY (Anton Rubenstein)

8" Underwater Design. Design may not exceed 8" in height and 5" in width. Fresh flowers only.

DIVISION II – HORTICULTURE HORTICULTURE RULES

(HB pp. 27-28, 53-57)

- 1. The NGC exhibit policies are printed in the Handbook for Flower Shows, Chapter 6, Exhibiting in the Horticulture Division.
- 2.All General Rules on pages 6-7 of this Schedule apply.
- 3. The rules for a single species cut or container-grown specimens are listed in the Handbook for Flower Shows or its supplement Horticulture Exhibiting and Judging.
- 4. Horticulture entries are open to all members of NGC affiliated garden clubs and all amateur gardeners
- 5.Advance registration of all entries must be made with Horticulture Entries Chairman Ali Hooker (phone: 772.233.6170, email: alihooker@aol.com) no later than February 13, 2023. The Entries Chairman will provide registration forms and blank entry cards.
- 6.Entry cards are to be filled out in advance, if possible, by the Exhibitor. The cards should be clearly legible and completed using pencil only, including the correct genus, specific epithet, and variety and/or cultivar for the specimen being entered. The common name may be added, but not substituted, for the current binomial name or scientific designation. A correctly filled out entry card example may be found in the Handbook for Flower Shows, Chapter 6 (p. 57).
- 7.In order to receive an NGC Top Exhibitor Award, the exhibitor must identify his/her entry by its binomial name or its currently accepted scientific identification as printed in the Handbook for Flower Shows, Chapter 6 (p. 54).
- 8.Only one plant per container is permitted. Plants that grow naturally with multiple stems will be considered one plant. More than one plant of the same species and color may be combined in the container to improve the overall appearance of the planting.
- 9.Entries of container-grown and mounted plants may be brought to the show venue entry hallway on Thursday, March 2, 2023, between 9:00am and 1:00pm. Cut specimens may be brought to the show venue entry hallway on Thursday, March 2, 2023 between 2:00pm and 3:30pm.
- 10.All horticulture specimens must be fresh plant materials grown by the exhibitor and all, except Arboreals, must have been in the exhibitor's possession no fewer than ninety (90) days prior to the Show. Arboreal (woody ornamentals) must be in the exhibitor's possession for at least six (6) months.
- 11.Cut annuals, biennials and perennials must have been in the exhibitor's possession from seeds, cuttings or immature plants and grown to maturity. Bulbous blooms must have been in

the exhibitor's possession from planting of bulb, tuber, corm, rhizome, or it must have been cared for as a mature plant for at least ninety (90) days.

- 12. For cut specimens, clear, colorless containers and clear plastic wrap wedging material will be provided by the Committee. For top-heavy cut specimens, exhibitor must supply clear glass beads or pebbles to stabilize container.
- 13.Cut specimens should not have foliage below the water line, except for *Gladiolus*.
- 14. If a plant is considered a flowering plant, it should be exhibited as a flowering specimen. Foliage plants may flower but should be exhibited as foliage plants if they are grown for their leaves.
- 15. Specimens with a Class designation in the Schedule may not be entered in the "Any Other Worthy Specimen" Class.
- 16.Each Exhibitor is limited to no more than five (5) container-grown plants and/or no more than seven (7) cut specimens. Exhibitor may have more than one (1) entry per Class so long as each entry is a different species, variety, cultivar, form, or color.
- 17.For container-grown specimens, container size may not exceed 12" in height and/or inside rim diameter. Double potting is permitted if inner container is not visible. The overall mounted specimen size may not exceed 18" x 18" unless approved by the Horticulture Entries Chairman.
- 18.Exhibits must be disease free, properly groomed and presented in clean containers. Moss (including Spanish moss) is not permitted.
- 19.Plant material may not be altered by the application (treatment) of oil, commercial "shine" products or any other substances that may artificially change the specimen's natural color and texture. No wiring of specimens is permitted.
- 20.All entries and entry cards will be checked by the Classification Committee before being placed in the show venue hall.
- 21. The Classification Chairman may disqualify exhibits of inferior quality, not well groomed, or not conforming to the Schedule. The decision of the Classification Chairman is final.
